GOOD FOODS CO-OP CHARITABLE FOUNDATION REQUEST FOR GRANT PROPOSALS 2022



The Good Foods Coop Charitable Foundation is pleased to announce that qualified charitable organizations serving central Kentucky are eligible to apply for funding. Organizations may submit only one request per grant cycle.

Funding priority Areas include:

- Development of the local food system and the local foodshed serving the central Kentucky region
- Promotion of food citizenship
- Increase of access to healthy food for all
- Promotion of the cooperative business model

<u>Deadline to apply</u> Please upload a two paged (max) proposal (three pages if needed for budget) in a PDF file format by 4:00 p.m. on **March 25, 2022** via the <u>Online Submission Form</u>.

Grant Amount Funding requests should range between \$500 and \$2,000.

Project Period Projects are anticipated (but not required) to be implemented within 12 months.

<u>Proposal Contents</u> Uploaded document (2-page max) must be clearly labeled to include:

- Organization's name and point of contact
- Project Title and detailed description of project, including timeline
- Description of how the project will impact one or more of the funding priority areas (above)
- Amount requested
- Detailed budget narrative (itemized costs) may be additional page if needed
- Anticipated outcomes of project and measurement

Eligibility

- All <u>501(c)3 organizations</u> that wish to apply for grants must have a profile created on <u>Guidestar.org</u> with a <u>gold level of transparency</u>. For convenience and check of eligibility, the Bluegrass Community Foundation hosts a searchable list of Kentucky non-profits registered with GuideStar called the <u>Kentucky Nonprofit Directory</u>. - <u>Public schools</u> and <u>exempt governmental units</u> that wish to apply will be asked to provide alternate documentation for eligibility purposes. Contact <u>Goodfoodsfoundation@gmail.com</u> to inquire about the alternate documentation.

Review Process The Good Foods Charitable Foundation's volunteer Board of Advisors will review the applications and determine awardees based on the proposal's strength of alignment with the priority areas. Organizations may be asked to provide additional information. Additional consideration will be given to organizations who have not received funding from the Good Foods Co-op Charitable Foundation in the last 3 years nor been the recipient of the Good Food Co-op's <u>Give Where You Live Program</u> in the last 3 years.

<u>Award Notification</u> Applicants will be informed of grant decisions by April 11, 2022. Awarded organizations are asked to have a representative attend the Good Foods Co-op Annual Owners Meeting, May 1st, 2022, at the Co-op from 3:00-5:00 pm for presentation of the award.

Reporting A follow up report detailing how the funds were used is expected in March 2023.
